Gabriella Nicosia, graduated in law from the University of Catania with 110/110 and praise, she completed her doctoral studies in France, at the University of Paris X, Nanterre and at the Institute of La Defense, the deepening évaluation des politiques publiques issues and the responsibility of officials of Fonction Publique under the guidance of Professor Antoine Lyon-Caen.

Lecturer in several university Master (at the Universities of La Sapienza (Rome), Roma Tre (Rome), University of Sannio (Benevento) Catania, Magna Graecia (Catanzaro)), from 1999 to 2012 is a visiting professor, in courses and Master, National School of Administration (SNA) in the offices of Rome, Caserta, Bologna, Acireale, Reggio-Calabria; from 2013 is Professor temporary extension of the same SNA.

Since 2006 she is member of the Academic Board of the PhD in European Labour Law, today Theory and practice of social regulation in the EU, and she was tutor of the thesis some PhDs.
